#### Frequently Asked Questions

#### Q: What if I have more than one cost center and expense code?

A: Please use different lines in the Description on the Req to separate the product/service and the corresponding cost center and expense code.

#### Q: What if I don't know whether there is an existing contract and/or PO?

A: If you know the last Contract Owner/Buyer who worked on the contract/PO, you may contact them directly. You may also contact the Purchasing Manager for general inquiries. Otherwise, please leave blank or a note, and our team will check once the Req routes through and gets assigned to the appropriate Contract Owner/Buyer. Once the Req gets assigned, you will get an automatic notification of who the Contract Owner/Buyer is for that Req and ask that individual as to whether there is an existing contract/PO.

#### Q: What if I need more space on the Req?

A: If you have a quote/proposal from the vendor, you do not need to retype or recreate those line items on your Req. It is acceptable to aggregate the charges into a single line (or a few lines as needed to delineate different cost centers for specific charges). Just be sure the Req's ESTIMATED TOTAL contains the appropriate total funding, and the quote/proposal is attached to the Req.

#### Q: What if there is no associated dollar amount with this purchase?

A: If there is no dollar amount with this purchase, please use select "Contract Form 1" as follows:

### Contract Form 1 - value less than \$10K

Note that if it is a "no-charge," where there is contract value associated to the transaction, but there will be no outgoing dollars or payment by UCSF, such as for an equipment or software evaluation, please still select the corresponding Contract Form for the actual dollar value of the transaction. For example, if it is an evaluation for equipment that is \$250k, then use "Contract Form 4 – value less than \$500k," and follow the standard process.

#### Q: What if the contract is for UCSF providing services?

A: If UCSF is providing services to another organization or institution (ex: UCSF Pathology provides lab services to the VA), then please select "Contract Form 1." The manager who signs the Req should be the primary responsible UCSF manager or stakeholder overseeing the service.

#### Q: What if UCSF is not purchasing a product and/or service (i.e. Affiliation Agreement, MOU, etc.)?

A: If UCSF is not purchasing a service but a contract still needs to be established, please select the corresponding contract form for the value of the transaction.

If there is no dollar amount associated, please use "Contract Form 1."

For Affiliation Agreements, the manager who signs the Req should be the UCSF manager or stakeholder who is overseeing the program (i.e. internship, externship, preceptorship, etc.) and/or student and will be the main primarily point of contact with the Affiliate School.

For MOUs, the manager who signs the Req should be the manager or stakeholder who is overseeing or responsible for the objective and UCSF's responsibilities under the contract for the program, service, or project.

# Q: What if UCSF is currently engaging in exploratory discussions and require a Non-Disclosure Agreement ("NDA") and/or Business Associate Agreement ("BAA")?

A: Please submit a Req using "Contract Form 1" to initiate the request for an NDA or BAA so this gets documented, logged, and tracked in our system(s) accordingly.

#### Q: What if there is an existing agreement that is being amended but there are no additional expenditures?

A: Please contact the Contract Owner who had handled the agreement to determine what would be the best contract approach to take. If it is determined that a new contract Amendment does need to be signed, then please submit a Req using "Contract Form 1" assuming there are no additional expenditures. Otherwise, submit a Req using the Contract Form that corresponds to the dollar amount.

#### Q: What if I want to terminate an existing agreement?

A: Please contact the Contract Owner to consult on the terms of the existing agreement to determine the appropriate steps and the basis of the termination. Often times, UCSF can terminate for no reason by giving written notice of a specified number of days in the contract (ex: 60 days). Written notice may be informal, which may take form of an email from the Department; or it may be formal, which takes the form of a written letter from the Procurement Office. This depends on (1) the terms of the contract; and (2) the relationship and preferences of the parties. Please contact our Office for further consultation.
